The Agency for Workforce Innovation’s Office of Early Learning administers the school readiness program, the Child Care Resource & Referral program and the operational requirements of the Voluntary Prekindergarten program. Early learning programs increase children’s chances of achieving future educational success and becoming productive members of society.

Florida’s early learning programs are developmentally appropriate and research-based. They involve parents as their child’s first teacher, serve as preventive measures for children at risk of future school failure, enhance the educational readiness of eligible children, and support family education.
